

## **CTNext Higher Education Entrepreneurship Advisory Committee**

Minutes – Special Meeting

### **2. Strategy Discussion, Application and Review Process:**

Ms. Dodge gave a brief overview of the application and review process and the proposed timeline. She then discussed strategic next steps.

### **3. Recommendations to CTNext BOD, Final Decisions:**

Ms. Dodge discussed the proposal renewals:

- Entrepreneurship Foundation – Dale Jasinski

**Mr. Nicastro made a motion and Mr. Hamer seconded, and the Advisory Committee members voted to in favor of putting forth the recommendation for the Entrepreneurship Foundation in an amount not to exceed \$262,250, to be presented to the CTNext Board of Directors for approval.**

- reSET – Sara Bodley

**Mr. Nicastro made a motion and Mr. Hamer seconded, and the Advisory Committee members voted to in favor of putting forth the recommendation for reSET in an amount not to exceed \$26,639.**

- Southern Connecticut State University – Patrick Hedikamp

**Mr. Nicastro made a motion and Mr. Hamer seconded, and the Advisory Committee members voted to in favor of putting forth the recommendation for Southern Connecticut State University in an amount not to exceed \$58,444.**

- UConn EE-REU – Hadi Bozorgmanesh

**Mr. Nicastro made a motion and Mr. Hamer seconded, and the Advisory Committee members voted to decline the recommendations for UConn EE-REU therefore the motion failed and will not be presented to the CTNext Board of Directors for approval.**

- UConn Enhancing Connecticut Entrepreneurship Network – Leslie Shor

**Mr. Nicastro made a motion and Mr. Hamer seconded, and the Advisory Committee members voted to in favor of putting forth the recommendation for University of Bridgeport in an amount not to exceed \$120,000, to be presented to the CTNext Board of Directors for approval.**
